

## Terms and conditions of RAFA 2013 conference

### 1 Applicability

1. ### 3 Cancellation

2. Cancellation of participation in the conference:  
Cancellation before September 1, 2013 – refund 75%; no refunds after that date.  
Where an individual fails to attend and has not cancelled in advance, the full conference costs are also payable.  
It is acceptable to send a substitute to the meeting.

### 4 Changes to the program, location of the conference
